Press Release of Classis Central Ontario, September 13, 2013

On behalf of the convening of Burlington Ebenezer, br. Harpert Vanderwel calls the meeting to order. After reading1Peter 1:3-9 br. H. Vanderwel leads in prayer. He then requests the brothers present to sing Hymn 84. The delegates from the church at Toronto examine the credentials. All churches are lawfully represented. Classis is constituted. The following officers are appointed –

The chairman thanks the church at Burlington Ebenezer for their preparations for Classis and once again being the host. Under memorabilia the chairman noted the following:

- The church at Burlington-Ebenezer who extended a call to Rev. R.J. denHollander that he declined. This vacant church along with the churches at Flamborough and Bethel are commended to the care of the Lord.

- Classis receives the following reports

 - ii. From br. Harry Sloots, the Treasurer of Classis, indicating the financial activity in the past year, the current balance and the Regional Synod Assessment for 2014 (\$1.00 per communicant member). Classis sets the classical assessment for 2014 at \$1.00 per communicant member.
 - iii. From Burlington-Waterdown indicating that they inspected the books of the Treasurer of Classis and found them to be in good order.
 - iv. From the Committee for Needy Churches recommending that the assessment for 2014 be nil. Classis receives this recommendation with great thankfulness to the Lord that Jubilee Church no longer needs Classical financial support.
 - v. From Burlington-Waterdown indicating that they have not yet audited the books of the Committee for Needy Churches. Classis urges that this yet be done and reported to a subsequent Classis.
- Classis agrees to the request of Burlington-Ebenezer to appoint Rev. G. Nederveen as their counsellor.
