Press Release of Classis Pacific East, March 12, 2015

The minister of the convening church of Chilliwack, Rev. A. C. Pol, welcomed the delegates to classis. He requested the singing of Ps 1:1-3, after which he read Isa 26 and led in prayer. The credentials were checked by the delegates of the church at Aldergrove and found to be in good order. Rev. R. Janssen was seated as an advisor to Classis. Rev. R. Schouten served as chairman, Rev. A. C. Pol as vice-chairman, and Rev. B. Wielenga as clerk. Classis was constituted and the agenda was adopted.

The report of the church for auditing the books of the treasurer (Vernon) showed that the books are in good order. A report was received from the treasurer. A report of the church for inspection of the archives was received from Yarrow – these were found to be in good order. Question period according to Art. 44 of the Church Order was made use of. Several churches requested advice on matters pertaining to government of their churches.
