Press Release of Classis Pacific West, held April 11, 2017, in Langley, BC

On behalf of the convening church at Langley, BC, Rev. William den Hollander calls the meeting to order and opens the meeting with prayer and the reading of John 16:16-24, and then invites the delegates to sing Hymn 10. The credentials are examined by the delegates from the convening church of the previous classis, the church at Houston, and are found to be in good order. Classis is declared constituted and the officers suggested by the last classis are appointed: Rev. James Slaa, chairman; Rev. William den Hollander, vice-chairman; Rev. Ben Schoof, clerk.

The chairman thanks the church at Langley for hosting and presents the agenda for adoption.

The agenda is adopted with minor additions.

Rev. W. den Hollander signs the subscription form.

An opportunity is given to representatives of the Aldergrove Mission Board to provide a brief report on the mission work in Brazil and answer questions from the delegates. The chairman leads classis in prayer for that work.

An appeal was discussed in closed session.

The Willoughby Heights Canadian Reformed Church requests that the call and the acceptance of the call by Rev. R.C. Janssen be approbated by classis. Classis approbates the call after receiving the appropriate documentation from the Willoughby Heights Canadian Reformed Church according to C.O. Art. 5. Rev. William den Hollander is appointed to represent Classis Pacific West at the installation of Rev. R.C. Janssen on June 11, 2017, the Lord willing.

The treasurer report of 2016 regarding the financial situation of the Classis Pacific West Fund is received. The assessment for 2017 will be \$10, an increase to bring the fund up to a responsible level. The delegates of the church at Cloverdale, appointed to audit the Classis Pacific West Fund, report that the books are in good order. The treasurer is thanked for his work (*in absentia*) and is honorably discharged from his services.

A delegate of the church at Houston, the church responsible for inspecting the archives, reports on the state of the archives. Certain gaps in the archives are noted and appropriate arrangements are made after a discussion regarding what it is necessary to archive. The report is received with thankfulness and the Canadian Reformed Church at Smithers, responsible for the archives, is thanked for their work.

Classis adjourns for lunch.

It is noted with thankfulness that the ministry of the office-bearers is being continued and the decisions of the major assemblies are being honoured. Cloverdale takes the opportunity to ask the help of classis in providing pulpit supply. The request is granted.

Opportunity is given for the churches to share the status of any mission projects in which they are involved.
