Press Release of Classis Alberta Edmonton-Immanuel September 18, 2018

On behalf of the convening church of Edmonton-Immanuel, Rev. J. Van Spronsen called the meeting to order by reading 2 Timothy 2 and leading in prayer, remembering the following: the ongoing vacancies of St. Albert and Neerlandia-South and the calls that have been declined, the start of the new season of instruction at CRTS, the ongoing health concerns of Professor Geertsma and Dr. Gootjes, as well as his wife and family, and also Sr. Margaret DeJong, widow of Dr. DeJong. He then asked those gathered to sing Psalm 48:3,4. All are welcomed including Rev. Bill Pols as observer from the URCNA.

The observer from the URCNA, Rev. Bill Pols was given the opportunity to address Classis and pass on greetings. The chairman responded with some appropriate words.

Personal Question Period was made use of. Brotherly Censure, per Article 34 of the Church Order was deemed with thankfulness to not be needed. The acts and the press release were adopted and the chairman closed Classis by leading in prayer and requesting the singing of Psalm 122:1,3.
