
Esteemed brothers,

Since our last report to Synod Winnipeg 1989 we, as address church for the Canadian Reformed Churches in Canada, received the following correspondence.

1. The Ecumenism Research Agency in Wylie, Texas, informed us in a letter dated June 1989, that it has stopped compiling information on the churches. In the past we have sent each year a Yearbook when requested.
2. During the years 1989 through 1991 we received requests for data on the Canadian Reformed Churches for the *Yearbook of American and Canadian Churches*. Each year we have supplied the pertinent information.
3. In March 1992 we received a letter from Mr. Richard Vaughan of New Market, On. As part of a course requirement in Missiology he mailed us a "Church Growth Statistics Questionnaire". We complied with his request as much as we were able.
4. In March 1992 we also received a letter from Mr. R. Ian Savage of St. Stephen, NB, expressing his interest in the work and ministry within the Canadian Reformed Churches. We informed him of the requirements for the ministry within the churches.
5. On August 20, 1992 we received a request from the Ontario Bible College in Willowdale, requesting a directory of the churches. Since we sensed from the letter that the Ontario Bible College wanted these addresses in order to send school promotion material, we have not responded to their request. We felt that the churches receive enough non-ecclesiastical mail as it is. If General Synod disapproves of our action in this matter we will hear so in due time.

All the correspondence we received and mailed out is included with this letter for your perusal and for filing in the archives of General Synod.
