Dear Reverend Van Popta:

The 1964 Synod of the Christian Reformed Church appointed a special contact committee to communicate with the Canadian Reformed Churches with a view to establishing a closer relationship with these churches.

In behalf of this Committee I address myself to you because one of the brethren told me that you are the name and the address of the 1965 Synod of your Churches. Anyway, I kindly call in your help for the following:

- a. Is there an official Standing Committee or Study Committee of your Churches for matters such as these? If so, please tell me the address.
- b. If there is not such a Committee, please tell me how our Committee can communicate with your Churches re this matter.

Our Committee met for the first time in Toronto on November 13, 1964. This meeting resulted in the idea to find out - in co-operation with your Churches - the procedure to follow. In our humble opinion we thought it advisable to have a kind of preliminary meeting with the Standing/ Study Committee or an other offical agency of your Churches. In this meeting which then will be of a more or less informative character we could together work out the line to follow for the real discussions and deliberations.

We come up with this idea because of our earnest desire to prevent any technical obstacle at the start of our endeavours to communicate with your Churches.

In case this informative meeting can be organized, we'd suggest that this meeting will be held in the Toronto area. But in this matter too your suggestions are very welcome.

Our general synod 1962 appointed us , to draft a letter to the forthcoming Synod of the Christian Reformed Church with copies to the consistories of that Church with regard to the Christian Reformed Church's correspondence with the (Syn) Reformed Churches of the Netherlands and her decisions in connection with the objections of some of her own members to this correspondence, as e.g. the changes in the Church Order, which have been proposed; and to call upon them to return from this course of action, so that the unity of the people of God in these countries be restored".

As may appear from this decision, our task was to draft a letter, to send it to your synod and also to send copies to the consistories of the Christian Reformed Church. This we did, and we have further fu authority to deal with any other matter. In our letter we offered to give more information about what we wrote, if so desired, but that would be all we were authorized to do.

I must, therefore, inform you, that there is no official Standing/Study Committee as menat by you.

We hope to have another general synod this fall. And since the Church at Edmonton, Alta, is the convening Church for this synod, it would be appreciated if you would send any communication for this synod to my address.
