



**ON THE ARCHIVES OF THE
CANADIAN REFORMED CHURCHES**

1989 - 1992

Submitted to the General Synod Lincoln 1992.

August 10, 1992

Esteemed brothers,

Since our last report dated January 1989, the building of the Church for keeping the Archives, burned down on October 3, 1989. The steel cabinet in which the documents were stored, was damaged but the documents were all intact.

The cabinet is replaced by a new one and the documents are professionally treated for smoke damage. The insurance policy of the Ebenezer Church covered the cost of the new cabinet and also the treatment of the documents.


Since our last report the following items are listed and orderly filed:

- All documents pertaining General Synod Winnipeg 1989.
- Extra copies of the Acts of Synod 1989.
- In 4 Binders documents of the "Committee on Relations with Churches Abroad" covering the period 1972 - 1977.
- Five Binders with documents pertaining the "Committee Book of Praise", donated by Mr. M. M. DeGroot, former Committee member.
- Correspondence and minutes of meetings held by the "Directors for training for the ministry" (1965-1965).
- Yearbooks published by "Premier Printing Ltd." of 1989, 1990, 1991 and 1992.

As instructed by General Synod 1989, Acts of Classes and of Regional Synods and also local Church Bulletins are disposed.

In 1990 assistance is given to an University student by providing foto copies of documents pertaining official contact with the Christian Reformed Church and with the Protestant Reformed Churches in the U.S.A.
