Esteemed brothers:


Attached please find a financial report of the General Fund as submitted by the book-keeper. The deacons were appointed by the consistory to audit these books. Attached please find a copy of their report. Our book-keeper noted that the required income comes to about \$1.00 per communicant member per year. He noted that many of the churches were confused thinking that the requests which were made are annual requests. Our book-keeper therefore suggests that for the next three years the churches be levied \$1.00 per communicant member per year. This will also help the churches to properly make their local annual budgets. If synod does not object, this is the procedure which we will follow until next synod.
